Tax Canons Academy, Canada as mentioned below:-

2. If he applies for lien/interruption while staying abroad while on lien and not joining the University service, the date of lien/interruption shall be fixed in his favor on the previous day of the last sanctioned lien i.e. his last working day in the University;

3. The period of employment during which there is no salary allowance in accordance with Government Decisions/Rules, lien shall not be counted as period of employment. That is, the period during which the appointing authority refunds/withdraws the salary allowances shall not be treated as pensionable service;

4. Government service rules, pension rules, circulars, office orders, instructions and decisions issued by the Government of the People's Republic of Bangladesh from time to time adopted by the

University shall be applicable;
