Professor Dr. Muhammad Sayeedul Haque, Department of Agricultural Finance and Banking who was granted lien for the period from 20.11.2022 to 19.11.2024 under this office order No. Sec-2/A-159/2002/778/Estt. dated: 06.10.2024 is allowed to keep lien to his post at this University for a further period of 3(three) year from 20.11.2024 to 19.11.2027 to work as a Training and Development Specialist at Tax Canons Academy, Canada as mentioned below:-

2. If he applies for lien/interruption while staying abroad while on lien and not joining the University service, the date of lien/interruption shall be fixed in his favor on the previous day of the last sanctioned lien i.e. his last working day in the University;

3. The period of employment during which there is no salary allowance in accordance with Government Decisions/Rules, lien shall not be counted as period of employment. That is, the period during which the appointing authority refunds/withdraws the salary allowances shall not be treated as pensionable service;

4. Government service rules, pension rules, circulars, office orders, instructions and decisions issued by the Government of the People's Republic of Bangladesh from time to time adopted by the University shall be applicable;

This order is issued in pursuance of the Syndicate resolution No. 20 dated: 09.01.2012, the decision No. 17 taken in the 324<sup>th</sup> online (virtual) session of the Syndicate held on 03.12.2022 and the Ministry of Education, Government of the People's Republic of Bangladesh, Office Order. 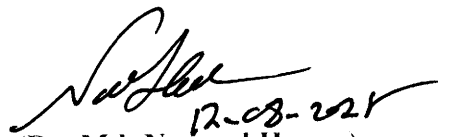
