Professor Dr. Md. Ashraful Islam, Department of Horticulture who was granted lien for 3(three) months from 01.01.2024 to 31.03.2024under this office order No.Sec.-2/A-9/2004/1169/Estt. dated 24.12.2023 is allowed to keep lien to his post at this University for a further period of 3(three) years 9(nine) months from 01.04.2024 to 02.01.2028 to work as a Research Fellow position in collaborated project of La Trobe University, Victoria and Department of Agriculture and Fisheries (DAF), Queensland, Australia as mentioned below:

- 2. He shall be bound to return to this University immediatly after completion of lien and shall also serve this University for a minimum period of 2(two) years 2(two) months 5(five) days.
- 3. If he applies for lien/interruption while staying abroad while on lien and not joining the University service, the date of lien/interruption shall be fixed in his favor on the previous day of the last sanctioned lien i.e. his last working day in the University;
- 4. In case of breach of the conditions of the bond executed, the amount of salary allowance received/to be received during the period of educational leave shall be refundable from him with 15% simple interest. The period of employment during which there is no salary allowance in accordance with Government Decisions/Rules, lien shall not be counted as period of employment. That is, the period during which the appointing authority refunds/withdraws the salary allowances shall not be treated as pensionable service;
- 5. If, after joining the University as a self-employed person after joining the university as per the terms of the executed bond, he applies for voluntary retirement/interruption without completing the period for which he is committed to serve, in that case, the period he will serve shall be adjusted proportionately to him. The salary will be withdrawn from him and the pension case will be settled as per Government/University rules after determining his actual length of service accordingly:
- 6. Government service rules, pension rules, circulars, office orders, instructions and decisions issued by the Government of the People's Republic of Bangladesh from time to time adopted by the University shall be applicable;
- 7. If he does not return to the University in due course, the University authorities may recover him one-time pension and the entire amount of his status in the Provident Fund to compensate his outstanding bond. He will have no objection to it and his heirs in his absence will have no objection and objection will not be legally admissible;
 - 8. After joining his office he will submit a report to the ministry on the knowledge achieved in the Research Fellow;
